What is the overall deductible ?	\$2,500 individual / \$5,000 family. Co-insurance and co-payments do not apply to the deductible . This benefit combines your prescription drug and medical deductibles .	Generally, you must pay all of the costs from providers up to the deductible amount each plan year before this plan begins to pay. If you have other family members on the policy, the overall family deductible must be met before the plan begins to pay. Your plan year: 01/01/2018 through 12/31/2018.
Are there services covered before you meet your deductible ?	Yes, preventive services	This plan covers some items and services even if you haven't yet met the deductible amount. But a co-payment or co-insurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	No. There are no other specific deductibles .	You don't have to meet deductibles for specific services.

What is not included in the out-of-pocket limit ?	Premiums, balance-billing charges, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .
